- 250 available for existing Cordillera Signature Golf Members
- Membership deposit of \$165,000 or upgrade of \$50,000 for existing Members
- Includes Generational Privileges for adult children and parents of Primary Member at Cordillera
- Affiliate Club privileges for Premier Members at Mayacama Golf Club
- Transferable Membership option through the Club and Cordillera Property ownership
- 80% Refundable per Membership Plan
- 2010 Membership Dues are \$12,250
- \$1,750 Club Minimum

Charter Membership

- Available for all applications including Cordillera property owners and non-property owners.
- Membership deposit of \$145,000 or upgrade of \$30,000 for existing Members

- 80% Refundable per Membership Plan

Signature Golf Membership

- Available for all applicants including Cordillera property owners and non-property owners
- Membership deposit is \$115,000
- Transferable Membership option through Club
- 80% refundable per Membership Plan

- 2010 Membership Dues are \$12,250
- \$1,750 Club Minimum

Gold Medallion Membership

- Available for applicants **who do not own property within the Cordillera Communities.**
- Non-Refundable Membership deposit is \$75,000
- Non-Transferable
- 2010 Membership Dues are \$12,250
- \$1,750 Club Minimum
- Limited availability

Social Membership

- Available for all applicants including Cordillera property owners and non-property owners
- Membership deposit is \$20,000
- Non-Transferable Membership
- Social memberships will not be refundable
- 2010 Social Dues are \$4,300
- \$1000 Club Minimum

Junior Golf Membership

- Applicants must be less than 40 years of age
- The Junior Membership deposit is \$115,000
 - Upon application \$57,500 will be due.
 - On January 1st of their 40th Birthday year, \$28,750 will be due.
 - On January 1st of their 45th Birthday year, \$28,750 will be due.
- Membership is 80% refundable per the Membership Plan, upon full payment of the initiation deposit. If the full amount is not paid prior to resignation, the previous amounts contributed will be deemed forfeited.
- 2010 Junior Membership Dues are \$5,588. Dues for this category are 50% of full Signature membership dues. Half dues will remain in place until the year of their 40th birthday
- \$1000 Club Minimum
- A Financing option is available through Alpine Bank, if you would like to make payments in a different proportion
